### 2026 VENDOR APPLICATION AND CONTRACT

The Kentucky Horse Shows are completely outdoor events. You must either provide your own trailer, or tents may be rented through this contract. Vendors will be accepted as space permits. Priority will be given to Vendors attending the entire 7 week circuit. Vendors of certain products may be excluded based on prior sponsorship agreements. No specific Vendor location or "space" can be guaranteed. Vendors of food and beverage wishing to apply must make arrangements separately. Please contact Cindy Bozan at (859) 608-3709 for information. **Food and beverage vendors should not fill out this contract.** 

Vendors will be notified of space availability. Kentucky Horse Shows, LLC reserves the right to reject any Vendor application for any reason or withdraw acceptance for unacceptable conduct or such other reasons as deemed by Kentucky Horse Shows, LLC.

Receipt of application and fees is not an automatic guarantee of acceptance. Deposit of an applicant's check does not guarantee acceptance as a Vendor. In the event that your application is not accepted, you will be notified and your deposit will be fully refunded. Once a Vendor is accepted, your deposit will be treated as a non-refundable deposit to be applied toward the total amount due. You will be invoiced for the remaining balance once accepted. Balance must be paid 30 days prior to the start of the first show you will be attending.

Please be advised that your application does not constitute a contract with Kentucky Horse Shows, LLC until each of the following requirements is satisfied:

- 1) You have been notified in writing that you have been accepted as a Vendor
- 2) The deposit of \$200 per week must accompany your application.
- 3) Vendor must provide **certificate of insurance** in the amount of \$1,000,000 per occurrence in Combined Single Limit Bodily Injury and Property Damage insurance naming Kentucky Horse Shows, LLC as an additional insured and the Kentucky Horse Park as an additional insured landowner.

#### LOGO & BRANDING

The use of the Kentucky Horse Shows name and/or logo is prohibited unless prior written approval by Kentucky Horse Shows, LLC is obtained.

The US Pony Finals event name or logo cannot be used on merchandise without written permission from the United States Equestrian Federation (USEF). Contact Layson Griffin LGriffin@usef.org.

#### **PAYMENT**

- A deposit of \$200 per week is required with your application.
- Applications must be filled out completely (pages 2 & 3) and signed.
- Applications submitted without deposit payments will not be considered.
- Once acceptance is confirmed and amount due invoiced, the balance due must be paid 10 days prior to the start of the first show you will be attending

#### ARRIVAL & SET UP

**Vendor spaces** will be available on the Monday of each show week after 12 pm (noon) and must be vacated by 9:00 am on the Monday following unless prior arrangements have been made.

#### **SHIPPING & DELIVERIES**

Kentucky Horse Park Freight Handling information will be available once an application is accepted.

**NOTE:** There is a \$75 charge per pallet that requires the assistance of Kentucky Horse Show staff.

**If equipment is available**, the Kentucky Horse Park will bill separately for the use of a forklift or any other KHP equipment for deliveries. Please be prepared to pay the KHP for the use of equipment at the time of the delivery.
